European cavers and their organisations, all members of the FSE have expectations from the federation and it is our mission trying to satisfy these as much as possible but also with respect to the limited possibilities that the federation has.

Many years ago, the FSE has established commissions and working groups to give interested cavers from different organisations the possibility working together on dedicated topics. Debating on cave rescue topics or insurances for rescue teams are only two of many topics of the European Cave Rescue Commission (ECRC) while protection and conservation of caves and karst beside international cave politics and honouring successful and important projects with a protection label, are part the European Cave Protection Commission (ECPC). Both commissions saw an impressive growth in interested commission members and importance of our commissions cannot be underestimated.

Further documentation and study of salt caves in Mt. Sedom (Israel)

From 10 to 18 March 2023, the 3rd international expedition to the salt caves of Mount Sedom, organized by the Israeli Speleological Association (ISA), took place.

The expedition's main objectives were to re-survey the Sedom and Peteq cave systems as the current maps are from the 1980s. Both caves are located on the eastern side of Mt. Sedom and resurge to the Dead Sea.


The old map of Sedom Cave showed a length of 1,799 m. During the expedition, about 2.7 km were surveyed, new passages and new entrances were found (currently 9 in total) - some of them were surveyed, the others remained as objectives for future exploration. Sedom Cave resembles a complicated maze system with galleries on more than 5 levels.

Peteq Cave's old map displays only the main branch and the main pit with a current total length of ~200 m. Last winter a side gallery was discovered with a significant continuation that still needs much more exploration. This side gallery also contains beautiful and rare formations such as large salt crystals and beautiful salt stalactites.

On the last days of the expedition a completely new cave was found, named Erzsébet Cave.

Participants from 8 countries - USA, Bulgaria, Hungary, UK, France, Czech Republic, Germany and Israel - joined the expedition. The project was supported by a financial grant of FSE as well as a rope sponsoring from FSE's official partner Korda's (Spain).





Tipan Cave Expedition (Philippines) achieved its targets

A group of Belgian, Dutch and Philippino cavers revisited Tipan Cave in the Naga municipality of Zamboanga province on the island of Mindanao in March 2023. The cave and neighboring karst sites are part of the newly created Naga-Kabasalan Protected Landscape Area.

The objectives of the expedition were to finish all survey work in the Tipan cave system, identify and explore other caves in the area, assist with academic research, photo documentation, support local organizations and caving infrastructure as well as setting up an infrastructure for a multi-year project. Local scientists, cave enthusiasts and staff of the Protected Area were greately involved in the exploration work and their contribution proved to be indispensable for the success of the expedition.

Until 2020 Tipan Cave was surveyed to about 9 km in length. The 2023 expedition ended with a total of 11,171 metres mapped in the cave system. Several nearby caves, mainly in the north of the system, were discovered and mapped, with future options to link them to the Tipan system. Fourty-eight cave entrances are now registered in the Protected Area. The German Speleological Federation, in co-operation with the IUCN/WCPA Geoheritage Specialist Group/Cave and Karst Working Group, and the BUND Thuringia, Saxony-Anhalt, and Lower Saxony, conducted the above-mentioned symposium between 1st and 4th June 2023.

The following 3-day symposium gathered participants from nature protection NGOs, the gypsum industry, nature protection authorities (e.g. the EU Commission), and speleological federations (including FSE president J.-C.Thies) to improve gypsum karst protection.

The symposium concluded with a field-trip in the surroundings of the village of Walkenried, during which the problems created for the partly old beech forests by gypsum mining on the gypsum hills was demonstrated.








The 2023 EuroSpeleo Protection Label goes to Ireland

The European Cave Protection Commission (ECPC) of the FSE is pleased to announce that, following the evaluation of the applications received, the EuroSpeleo Protectin Label 2023 has been awarded to the Cork Speleologial Group (CSG) from Ireland for their project "Digging into the Past: Preservation Ireland's Cultural Heritage through Cave Exploration".

Caves have been used for millennia as both a place of refuge and a sacred space, and Ireland's cultural heritage is often intrinsically tied to these places. Irish caves have significantly contributed to our understanding of past peoples and landscapes, with recent archaeological research from a number of caves drastically altering our knowledge of human and animal habitation in Ireland,



Comprehensive publication on the biospeleology of Spain released

The Sociedad Entomológica Aragonesa (SEA), in collaboration with the Spanish Federation Confederación de Epeleología y Cañoes (CEC) as well as many Spanish cave experts and biologists, has recently released the book "Habitantes de la Oscuridad. Fauna Ibleo-Balear de las Cuevas". The very well-produced book features over 700 pages a state-of-the-art compilation of the current knowledge on the Spanish biospeleology. and upcoming publications expected to advance the scientific record even further. The project 'Digging Into the Past: Preserving Irelands Cultural Heritage through Cave Exploration' will build strong relationships between archaeologists and cavers and help cavers understand the importance of preserving cultural heritage in any exploration, particularly where digging is involved.

The need for archaeological and cultural considerations when evaluating the significance of caves has been highlighted in the 'Guidelines for Cave and Karst Protection (2022)' and one of the key objectives of the ECPC is to generate knowledge about the scientific value of caves and karst, to identify and promote suitable and effective methods of their preservation. In line with this, technical guidance, in the form of a cavers handbook, on how cavers should proceed with cave exploration (particularly regarding sediments), in areas with the potential for significant cultural and heritage impact, will be produced and distributed. This work will be carried out by Cork Speleological Group in collaboration with experts from a number of research institutions, using both archaeologists expertise and cavers local knowledge to help preserve Irelands heritage.

The project received a financial grant of 800 EUR as well as equipment from FSE's official partner Aventure Verticale.

ECPC - Commission members for the next 4 years

Following the FSE GAM in Breitscheid, Germany on May 20th, the team of the European Cave Protection Commission now starts its work for the next 4 years (2023-2027).

17 members from 12 countries build the new commission and their ambitions are enormous as the protection of caves and karst play more and more an important role in Europe and elsewhere. The composition of the commission for the next years is as follows:



Some of the tasks of the commission are biospeleological research; pushing cleaning activities and leading cavers to 'sensitive caving'. And of cause the commission will work for the annual EuroSpeleo Protection Label, a Cave Protection Symposium in 2024, listing lost caves in Europe and collecting general data about caves in Europe. The commission further represents the FSE in international environmental organisations i.e. EEB. Many commission members are subscribed to working groups in EEB or other coalitions to represent FSE and to defend the interests of karst, caves and also groundwater.

EEB, the "European Environmental Bureau" (http://eeb.org) is the largest network of environmental citizens' organisations in Europe. It currently consists of over 180 member organisations in 40 countries, including a growing number of networks, and representing some 30 million individual members and supporters. The vision of the EEB is: A better future where people and nature thrive together.

Further EEB stands for sustainable development, environmental justice, global equity, transparency and participatory democracy. It promotes the principles of prevention, precaution and the polluter pays.

EEB is based in Brussels in Belgium and in 2024 the organisation will celebrate its 50 years of existence.

EEB also is a member of the "The Green 10". (https://green10.org).

FSE is a full member as "European Network Organisation" since 2011 and held a position in the EEB Board since 2015. As the EEB has changed its governance system in 2023, the seat of the FSE in the EEB Board has become a seat in the EEB Council. The current session with our mandate will run up to 2025. Note: Beside the FSE, there are also the German Federation VdHK, and the Italian Federation SSI, both national full members of the EEB.

Various members of our protection commission ECPC are subscribed to EEB Working groups like Biodiversity, Water, Soil, International Environmental Governance or Law and Justice in order to discuss and defend the interests of caves and karst beside groundwater and minerals (i.e. gypsum karst).

For this year's annual event held in Stockholm (Sweden) in early May, the ECPC President has been representing the FSE in internal meetings as Board, Council and General Assembly. Beside internal meetings, the EEB, together with the "Swedish Society for Nature Conservation (SSNC)" organised a public conference with the topic: "Our common future: For a European Green Deal 2".

New FSE working group "European Children and Young Cavers"

During this year's FSE General Assembly a new working group was officially established - European Children and Young Cavers (ECYC).

The ECYC intends to promote and support especially children and young cavers in speleology. Children are always open for new interesting activities, especially in nature. They do like sports and at the same time they are curious to discover and understand the world around them. But for children it is often more difficult to get in touch with the speleo community. Therefore it is only logical to focus with one working group especially on children and young people.

The European speleological community has gained knowledge and experience in underground exploration, science and protection, from which the next generation should benefit. There are already cavers, who are supporting young cavers and children on regional or even national level. The motivation of the ECYC is to unite our energy and experiences throughout Europe and develop further good practice examples on European level for the benefit of the next speleo generations.

The range of possible activities and projects is quite big, for example, preparation of educational material about cave related topics (e.g. science, cave protection, technics) in different languages, speleo training, support for science projects in schools and youth groups related to caves and karst, support for cave protection activities, support for mapping and cave photography workshops especially for young people, an online exchange platform especially for children and young cavers, Young Cave Art Contests, Support for Cave Photographer Workshops for children and young people and many more.

The first public meeting of the ECYC took place successfully at the EuroSpeleo Forum 2023 in Breitscheid (Germany).
